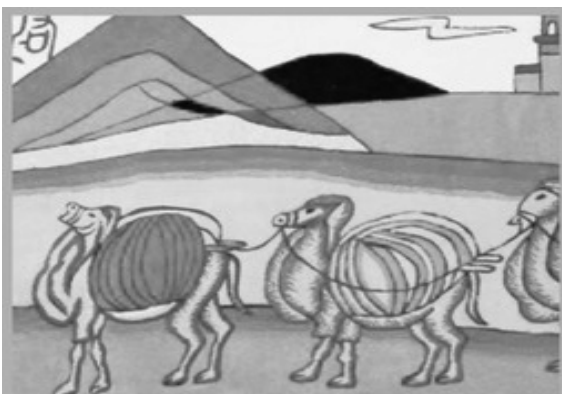
Prospective members and guests may attend up to three day or evening meetings each program year.

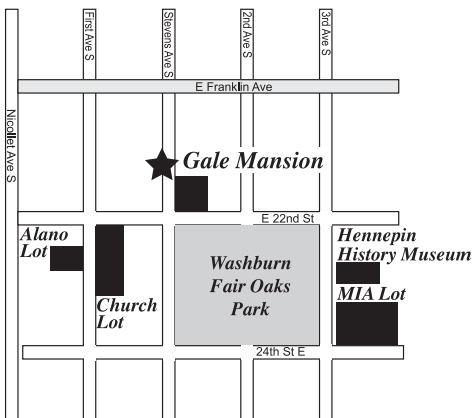

Minneapolis Branch Scholarship Fund

Meet Lulu Bauermeister

Scholarship winner Lulu Bauermeister is Chinese, adopted by the Bauermeisters when she was a baby. She is the second oldest of four Chinese girls in the family.

Over breakfast, June 26, Lulu revealed it was her 20th birthday. This young scholar's favorite comment is, "I'm so excited."

This past summer, she was excited to be one of the rowers in the boat entered by US Bank in the Dragon Boat Festival held on Lake Phelan. This was a fun part of her summer job as a corporate employee inclusion intern at the bank. "I just hope not to fall in," said Lulu, laughing. This is her second summer with US Bank working on diversity and inclusion projects, internal communications, and marketing.

This fall, she's excited to return for her junior year at University of Minnesota where she's majoring in physiology and minoring in public health and leadership. Her course load this fall will be organic chemistry, physics, and public health plus two field experiences, one at the University hospital--the other in leadership and career coordination. She named genetics as her favorite college subject. Like another of our scholars, Selam Girmachew, Lulu is planning to become a doctor.

Lulu is active in Minnesota Medical Leaders, one of several future-doctor organizations at the University. "There are 30 of us in the group, half women and half men," she explained. "We are focused on cooperating professionally--collaboration, not competition."

She is also looking forward to serve on the Homecoming Royalty Court this fall. After being nominated by her peers, she went through a group interview; it was right before spring semester finals and "pretty difficult." One of the 10 will be crowned Homecoming Queen--the others serve as her court.

Spring semester Lulu spent many hours on the field at the U with the track and field team. Now in her sixth year as a jumper, she is a record holder in triple jump and high jump.

“I started soccer when I was five,” she recalled. “And, I was on the girls basketball team at Washburn when we went to the state tournament.” She ran cross country in high school and still enjoys running.

Lulu has returned to China four times, going with a group from the Wishing Dream Foundation, taking blankets and toys to children there. She has also visited Haiti twice, terming the two-week visits “very humbling.” This June she was one of 900 participants in AAUW’s National Conference for Women Student Leaders at University of Maryland.

Besides the \$12,000 awarded her by our Branch, Lulu is supported by a scholarship from Wallin Education Partners.

Since the Scholarship Fund began in 2001, 18 women graduates from Minneapolis Public Schools have completed four years of college study with the help of AAUW Minneapolis Branch Scholarships for a total of \$216,000. Please consider donating to the AAUW Minneapolis Scholarship Fund!

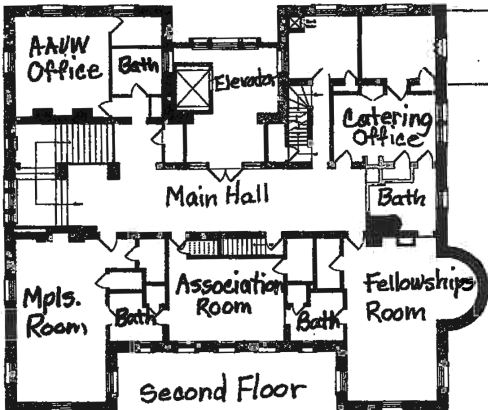
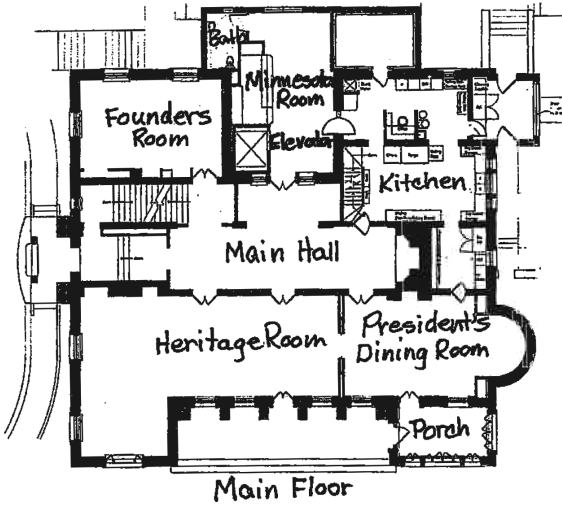

Detail restrictions if your diet is restricted for religious or ethical reasons. Please help the staff by providing suggestions of food items which will work for you.

On the day of the meal, pick up your **special diet card** in the lower level lobby. Display this card at your table, and alert the server as to your meal request.

A vegetarian meal is the only available alternative meal on Tuesday evenings.
